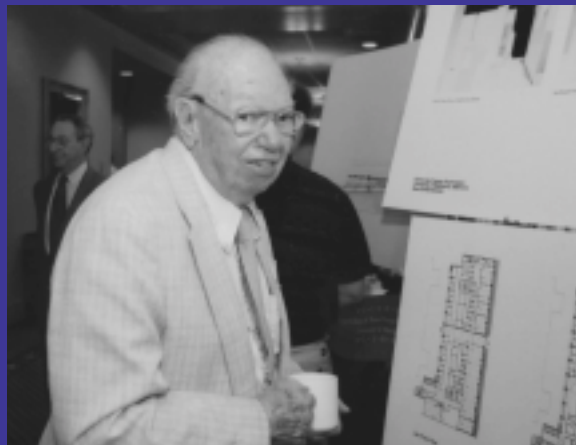


CLASS NOTES
