

Dear Incoming Student:

On behalf of Student Health Services at the University of Maryland, Baltimore – Welcome! Students may access details about services through our website: [Student Health Center- Student Health Resources \(umaryland.edu\)](https://umaryland.edu/student-health-center). We have implemented a new immunization tracking platform known as EXXAT for UMB Students. Please await further guidance via email for further information and upload instructions. In the interim gather and organize your immunization documents for future submission.

1. Provide proof of the following required titers and immunizations:
 - a. **Measles, Mumps, Rubella (MMR)- 2 vaccine dates/titer**
 - b. **Chicken pox (Varicella)- 2 vaccine dates/titer. History of disease is NOT acceptable.**
 - c. **Hepatitis B- 2 vaccine dates AND Hepatitis B antibody titer – within 12 months of start date.**
 - d. **Tetanus update within 10 years**
 - e. **Tuberculosis screening (Tspot/Tb Gold) AND TB questionnaire – within 12 months of start date.**
 - f. **If living on campus, provide proof of meningococcal vaccination within 5 yrs.**
 - g. ***Seasonal Influenza vaccine**
 - h. ***COVID-19 Vaccine dates and lot numbers. Primary series recommended (2 doses of Moderna/Pfizer).
Booster dose strongly recommended. Required for most students participating in clinical rotations.**
2. Health insurance waiver/enrollment for the Fall 2024- Spring 2025 academic year. ALL FULL TIME STUDENTS must provide documentation of active health insurance AND opt in/out of the UMB health insurance through Gallagher: [Benefits Dashboard- Gallagher Student Health and Special Risk](#). Students participating in clinical rotations are required to provide proof of COVID-19 and Influenza vaccination or approved waivers due to medical contraindications or religious exemptions. Students unable to obtain vaccine records can be tested and immunized at the University of Maryland Campus Health. If any titer is negative or equivocal you will be prompted to receive a booster(s) shot. Call 667-214-2233 to set up an appointment and self-scheduling is available for vaccinations only at [UMB Student Health Shot Clinic \(umfpi.org\)](https://umfpi.org). There may be a charge for laboratory services depending on your insurance coverage.

Noncompliant students will receive a HOLD on their registration account, preventing future enrollment. Please check with your school to see if they have additional requirements than those listed here.
